PRESIDENT'S MESSAGE

Happy Holidays!

We are in full holiday mode and another year is quickly closing. For many, it has been a difficult year. My Christmas wish is for a better year in 2010 for all those who struggled in 2009. It is also a time for reflection. Allow me to share some of my observations while visiting my parents over the Thanksgiving break.

My parents live near Rockford, Illinois. At one time (the 60's to 70's), I've heard that Rockford was near equal in size and economy to Madison. If you have visited Rockford in the last 5 years, that will seem surprising to you. However, Rockford does have a highly ranked children's museum, so when my children and I visit it is frequently a destination. I enjoy taking different routes through town to get to the museum. It is utterly amazing, shocking, and depressing all at once; think of the stories you hear about other Midwest towns or rustbelt cities. Picture block after block of abandoned and underutilized factories, buildings, homes, and other infrastructure.

Madison seems like an entirely different world in comparison. My thoughts are typically two-fold. One: what an amazing place it must have been -- busy, prosperous, and a great place to make a living and raise a family. Two: what a great opportunity if the Rockford economy was more like the Madison economy. Many of the abandoned buildings have unique architecture, and are located right along the Rock River. The redevelopment potential is boundless if business could just support it.

Later, back at my parent's place, I was talking with my father about his experience in the military in the late 1960's. He worked on a base where he assisted the post engineers. They were basically the maintenance folks on the base. He recalled problems they had with magnetic ballasts in their fluorescent lighting in a very large military finance building. They had two teams dedicated to changing the ballasts and bulbs. He recalled stories of the magnetic ballasts "leaking" a black sticky substance when they got too hot and failed. After some quick research I learned that the old magnetic ballasts had a tar substance in them used to dampen the buzzing noise often associated with them. Roughly a third of the teams' maintenance requests were for lighting problems. Oddly, too hot/cold temperature calls weren't the highest type of request! I love these stories, and I hang on every word. So much has changed in the built environment and yet some things are the same.

We are fortunate to be in Madison. It is a great city with more opportunity than many cities around us. We are fortunate to have great facility managers managing Madison's built environment to help ensure we remain competitive and viable into the future.


Executive Committee Meeting December 8, 2009

Enhancing Quality of Life at the End of Life

The next time you see Ron Galdes, make sure to congratulate him on his promotion to Director of Facility Support Services. Ron continues to manage the facility operations at HospiceCare Inc. but has the added responsibilities of food services and supply purchasing/distribution for the agency.

To function effectively as the HospiceCare facilities manager, it is important to understand the unique mission and goals of the agency. While the most visible part of their mission is the end-of-life care at the HospiceCare facility, a much larger part of their work is "field-based" via home-based support programs. The HospiceCare facility is both a hospital for inpatient care, plus a training center and meeting place for the field operations and the community.
