### April Meeting on Suzuki Challenges

The April Luncheon meeting topic was a lively networking program based on Dr. David Suzuki's 10 challenges to Conserve Nature for the Future. As part of this interactive program each table answered three questions relating to the Nature Challenge. Chuck Gifford provided a biography and background on Dr. Suzuki and the force of why this is being brought to our Chapter. Laura Huttner facilitated the luncheon exercise.

The questions posed were:

- 1. After reviewing the 10 challenges, list how many you are presently doing either at home or in your office;
- 2. How many other ways can you think to save nature either in your home or office;
- 3. List some ways you might be able to get your building occupants or others to take on the challenge or get involved.

We had 45 suggestions for #1, 31 for #2 and 25 for #3. This list will be sent out via email to all Madison IFMA members. Prizes were awarded to the two tables with the most suggestions. Table 1 with 39 suggestions received

a package of seeds. Table 1 occupants - Catherine Neumann, Rita Garcynski, Dan Drager, Tim Lerdahl, Steven Newcomer, Chris Beall, Joe Johnson, and Larry Barton.

Table 3 took 2nd place with 23 suggestions also receiving packages of seeds. Table 3 occupants - Ron Disch, Bonnie McCloskey, Mike Bergenske, Brad Harris, Karen Miller, Kent Hoffman, Gary Studebaker and Karen Suchomel.

### April Tour was Crescent Building

IFMA members toured the Crescent Building on March 29, 2004 at 5:00 p.m. The Crescent Building, located at 25 N. Pinkney St. was built in 1897 and offers an excellent view of the Capitol building from its front windows. Members attended the tour to see in person the "green" materials and techniques that Madison Environmental Group employed during their first phase of renovation. We also toured the areas under going renovation in Phase 2, which includes additional office space on the third floor, and the renovations to the facade and the first floor entrance. We reviewed the plans for the remodeling and the green roof.

Sonya Newenhouse and Maureen Mahle led the tour, answered questions and discussed their views on valuing people and their contributions over materials, and preferring to spend construction and office budgets on laborintensive recycled materials when the cost for newer or more convenient materials was substantially the same. During the seven weeks of the Phase 1 construction, the costs of "going green" were found to be equal to or less than the cost of traditional construction, and did not impact the overall schedule. Ms. Newenhouse also stated that no recyclable building materials had been stockpiled or preidentified before design and construction began. Desks and shelving units were hand-made by local craftsmen from recycled wood and glass with an eye to future reusability as well as current functionality and beauty. In fact, nothing in the office area appears to be second-hand or recycled or even below premium grade.

On a lighter note, we learned that in addition to being more energy efficient, a compact fluorescent bulb may actually be safer than an incandescent bulb. Ms. Mahle noticed what appeared to be bugs in the globe fixture above her desk earlier on tour day, and decided to clean them out. Upon removing the globe, she realized that it was completely full of water, the result of a roof leak, but the bulb remained functional during its dunking. We also were invited to inspect the worm bin and the resultant compost being stored on the fire escape. Their resident gardener is eagerly anticipating the arrival of spring.
